	Importation of drugs (including pharmaceutical products, active pharmaceutical ingredients, diagnostics and biological products) for human use requires either of the following: (1) a photocopy of the drug (import) license issued by the Ministry of Health and Welfare together with a photocopy of the license of the pharmaceutical firm; or (2) an approval issued by the Ministry of Health and Welfare.(3)Importation of drugs (including pharmaceutical products, active pharmaceutical ingredients, diagnostics and biological products) for research or experimental study use, an approval (having the special 14 codes on the import application) issued by the Ministry of Health and Welfare is required for customs clearance.
