This is a HAZMAT Training for students from South and East Asian Countries held by the National Yunlin University of Science and Technology Emergency Response Information Center, which is supported by the Toxic and Chemical Substances Bureau, Environmental Protection Administration.

The Chemical Disaster Training will be held from <u>January 17<sup>th</sup></u> to <u>19<sup>th</sup></u>, <u>2022</u>, which will be a three-day course at the National Yunlin University of Science and Technology. - > Students major in departments relating to Chemicals (Engineering), Environmental (Engineering), and Occupational Safety and Health.
- ➤ Preference is given to Graduate and Doctoral Students. College Students are welcomed to apply as well.
